#### **Public Hearing County and Town 2024 Budgets**

Public Hear was called to order by County Chairperson, Beth Moses at 5:00pm. Administrative Coordinator, Jeremy Weso reviewed the County budget. He presented the balanced budget to the community. He had one public hearing comment on the FY2024 County budget. The proposed budget that was published includes a \$19,709 levy adjustment, which reflects the amount of the increase we are anticipating in the Public Health agreement with Shawano County. The committee approved the reduction in available levy from \$2,881,219 to \$2,861,510; more specifically, such was accomplished by reducing tax levy revenue for the Board form \$41,026 to \$21,317 and reducing Contingency from \$41,026 to 21,317.
